ACCEPTANCE OF TERMS AND CONDITIONS - DECLARATION OF CONFORMITY

This document is structured in four sections setting the terms and conditions for participating in any OWS race, mentioned above, in Navia 2017 and promoted by the *Asociación de Amigos de la Ría de Navia/ARN*. It must be duly completed and handed in along with proof of identity and age (e.g. ID photocard, swimming license, passport...) at the time of collecting the transponder. Otherwise, swimmers will not get their transponders and will not be allowed to take part in the *Descenso* and/or *Copa Asturias*. The organizing committee reserves the right to reject any registration (even forcing the swimmer to retire from the competition) failing to comply with this requirement.

In compliance with article 5 of the Organic Law, 13th December, of Personal Data Protection, we would like to inform all people completing this "Acceptance of terms and conditions - Declaration of conformity" form that personal data supplied here will be incorporated to a file under the responsibility of the Asociación de Amigos de la Ría de Navia/ARNavia with the only purpose of managing maintenance and compliance. 1] Declaration of swimming ability

The swimmer signing this document (underage swimmers represented by a parent or legal guardian) states having voluntarily joined this competition and any activity linked to it and declares to being trained and fit to participate in the race and declares not having been advised against participation by a doctor.

2] Waiver/release of liability

The swimmer recognizes and understands that there are risks inherent to the competition, including but not limited to, paralyzing injuries and death and agrees to hold harmless and not to sue under any circumstances, from any liability the promoter entity (*Asociación de Amigos de la Ría de Navia/ARN*), the organizing committee or sponsors, and any other person or entity involved in the competitions' organization. Such disclaimer extends to any possible complaint filed by relatives, or any other third person or body or association, claiming swimmer's rights.

The swimmer also accepts that the *Asociación Amigos de la Ría de Navia/ARNavia* organizing committee, or any other person/entity involved in the organization is not liable for any damage, loss, or theft of property that may happen in the competition's premises, and agrees to refuse on his/her behalf, and also on behalf of third parties, to any compensation claim.

3] Consent to an emergency services intervention

The swimmer expresses his/her consent to be assisted, if needed, by the emergency services and doctors arranged by the organizing committee and, similarly to section 2, holds harmless from any liability the *Asociación Amigos de la Ría de Navia/ARNavia* organizing committee, or any other person/entity involved in the organization, and mainly, the assisting staff and medical services.

4] Authorization for use of image and public publishing of the rankings

The swimmer gives consent to *Asociación Amigos de la Ría de Navia/ARNavia* to use any kind of electronic report (i.e. pictures, videos, audio recordings...) for information or advertising purposes, and releases *ARNavia* from any liability derived from the use of those records. Copyright will not be property of the swimmer, who refuses to demand any kind of compensation to *ARNavia*, the organizing committee, or any

other person/entity involved in the organization. Such disclaimer extends to any possible complaint filed by relatives, or any other person, claiming swimmer's rights. For its part, ARNavia expresses its commitment not to commercially exploit such records without the swimmer's express consent.

The swimmer recognizes the right of ARNavia and the organizing committee to use the swimmer ID number to publish in its social media pages, the swimmers list for pre-registration and registration in the *Asturias Cup*.

The swimmer also recognizes the right of ARNavia and the organizing committee to publicly publish the rankings. Those rankings may include swimmers' name and surname, the place won in the competition (and, if appropriate, *withdrawn, disqualified or non-qualified*), the club he/she belongs to, the age group and the time spent for completing the race.

Finally, the swimmer declares:

- to know the competition rules (the General Rules and related documents) and to accept them
- that holds a coverage insurance valid in Spain covering any medical and transportation expenses that may incur regarding its participation in any of the races and its stay in Navia or its vicinity
- to have read and to accept all the sections on this document (*Acceptance of terms and conditions - declaration of conformity*)
