



Swimming competitions on river Navia 2018

***LXI DESCENSO A NADO DE LA RÍA DE NAVIA*– 29th July 2018**

***XX OPEN WATER SWIMMING ASTURIAS CUP*– 28th July 2018**

REGISTRATION REQUIREMENTS

By registering for any of the abovementioned competitions, the swimmer declares:

- 1) to understand the *General Rules* (and related documents) for the specific competition, and to accept them;
- 2) to voluntarily participate in that competition and any activities related to it;
- 3) to be trained and fit to participate in the competition and states no medical advise against participation;
- 4) to recognise and understand the risks inherent in the competition –including paralyzing injuries or death– and agrees to hold harmless from any liability the promoter entity (*Asociación de Amigos de la Ría de Navia/ARN*), the Organising committee or sponsors, and any other person or entity involved in the competitions' organisation. Such disclaim extends to any possible complaint filed by relatives, or any other person, claiming swimmer's rights;
- 5) to hold a coverage insurance valid in Spain covering any medical and transportation expenses that may occur regarding the participation in any of the races and the stay in Navia or its vicinity;
- 6) to accept that the *Asociación Amigos de la Ría de Navia/ARNavia*, the Organising committee, or any other person/entity involved in the organisation is not liable for damage, loss, or theft of property that may happen in the competition's premises, and agrees to refuse on his/her behalf, and also on behalf of third parties, to any compensation claim.
- 7) to give consent to *Asociación Amigos de la Ría de Navia/ARNavia* to use any kind of electronic report (i.e. pictures, videos, audio recordings...) for information or advertising purposes, and releases ARNavia from any liability derived from the use of those records. Copyright will not be property of the swimmer, who refuses to demand any kind of compensation to ARNavia, the Organising committee, or any other person/entity involved in the organisation. Such disclaim extends to any possible complaint filed by relatives, or any other person, claiming swimmer's rights. For its part, ARNavia expresses its commitment not to commercially exploit such records without the swimmer's express consent;
- 8) to recognise the right of the *Asociación Amigos de la Ría de Navia/ARNavia* and the Organising Committee to use the swimmer's ID number to announce on the official social networks the list of people who have successfully pre-registered and registered for the Asturias Cup, and to publicly spread the rankings of the races. Those rankings may include swimmers' name and surname, the place won in the competition (and, if appropriate, *withdrawn, disqualified or non-qualified*), the club he/she belongs to, the age group and the time spent for completing the race;
- 9) to have read and to accept all the sections on this document (*Swimming competitions on river Navia 2018 – registration requirements*).

Underage swimmers need to have these requirements read and accepted by a parent or a legal guardian. This is compulsory for any underage swimmer who wants to complete the registration process.
